A nominating petition **SHALL** be submitted to the Registrar of Voters in the Parishes where the signers reside **no less than 30 days before** the qualifying period ends for candidates in the primary election. For a special election called pursuant to La. R.S. 18:402(E), La. R.S. 18:601(A)(2) for a legislative vacancy, or La. R.S. 18:1279 for a congressional vacancy, the petition **SHALL** be submitted by the candidate **no less than 14 days before** the qualifying period ends.
