NOTES:

<u>1998 ELECTIONS</u>--<u>PROPOSITION ELECTIONS</u> may be held on the third Saturday in January (except Orleans in 1998), on the third Saturday in July, or on the two primary/general election dates each year.

<u>VACANCIES</u> may be filled at the spring/fall candidate elections scheduled in any given year, depending on when the vacancy occurs and when the proclamation calling the special election is issued.

Exceptions to filling vacancies on the above dates:

- 1. The Governor may specify election dates in the proclamation calling the special election for the following offices: U.S. Representatives; Judges; and Justices of the Peace.
- 2. The President of the Senate specifies the election dates in the proclamation calling the special election for State Senator.
- 3. The Speaker of the House of Representatives specifies the election dates in the proclamation calling the special election for State Representative.

NEW ORLEANS MUNICIPAL AND PAROCHIAL ELECTIONS -- 1998

- 1. May not use third Saturday in January 1998 for proposition elections.
- 2. May not use the spring municipal primary election date in 1998.
