-RECOGNIZED POLITICAL PARTIES-

Qualifying Information for President (Electors)

STATE OF LOUISIANA

Presidential Election November 5, 2024

Candidates for presidential elector for political parties that are recognized in Louisiana (Democratic, Green, Independent, Libertarian, and Republican) shall file the following materials with the Louisiana Secretary of State's office:

1. Certificate of Nomination (La R.S. 18:1253)

- A. The certificate of nomination is a document created by the party that shall be sworn to, signed, and filed by one of the following:
 - 1. The chairman and secretary of the state central committee;
 - 2. The chairman and secretary of the convention, if nominating the presidential electors by convention; or
 - 3. The national chairman, if the chairman and secretary of the state central committee or the chairman and secretary of the convention fail to submit the required documents by the **August 20**, **2024** deadline.

B. Deadlines

- 1. **August 20, 2024, 4:30 p.m.** The deadline for the chairman and secretary of the state central committee or the chairman and secretary of the convention to file the certificate of nomination, the slate of candidates for presidential elector, and the affidavits of acceptance for each presidential elector (La R.S. 18:1253(E); or
- 2. **August 23, 2024, 4:30 p.m.** If the state central committee does not file documents by **August 20, 2024**, the deadline for the national chairman to file the certificate of nomination, the slate of candidates for presidential elector, and the affidavits of acceptance for each presidential elector. (La R.S. 18:1253(E)
- C. The certificate of nomination shall include:
 - 1. The names of candidates for presidential elector (Eight total: six from each congressional district and two at-large);
 - 2. The residence address of each presidential elector;
 - 3. The presidential elector's congressional district or at-large;
 - 4. The name of the recognized political party making the nomination; and
 - 5. The names of the candidates for president and vice president.
 - 6. Certification of the adoption by the state central committee of the resolution of the committee which authorized the method of nomination, the method of nomination used, and the time and place where the nomination took place. Or, if the state central committee ordered the nomination of presidential electors by a convention, a certification of the adoption by the state central committee of the resolution authorizing a convention, the time and place where the convention was held, and the election of the chairman and secretary.

2. Eight (8) Affidavits of Acceptance of Nomination (La R.S. 18:1253(C), 1253(E), 1253(F))

- A. Each candidate for presidential elector, signifying their acceptance of the nomination, shall:
 - 1. Include their name and residential address;
 - 2. Provide congressional district or at-large that they will represent;
 - 3. List the names of their party's presidential and vice-presidential candidates;
 - 4. Sign an affidavit signifying their acceptance of nomination.
- B. The affidavit must be an original and be a notarized document.
