- * This petition shall be submitted to the parish registrar of voters within one hundred eighty days of the date of the first signature.
- This petition shall include an Attachment A, which provides the name of each home rule charter commission district, along with the number of commissioners to be elected for each district.
- This petition shall include an Attachment B, which lists the precincts to be included in each home rule charter commission district, or which specifies the precincts to be used in each district by reference to other election districts established by law or local ordinance.
- When certification of this petition is definitively established in accordance with R.S. 33:1395(D), the offices of home rule charter commissioner are at that time established and vacant. The governing authority of the municipality or parish shall call an election to fill the commissioner offices within thirty days. The election shall be held on the next date allowed under the provisions of R.S. 18:402 for a primary or general election, special election, or bond, tax, or other election. Any such election shall otherwise be held pursuant to and in accordance with the Louisiana Election Code.
